Educators and Legislators Discuss School Funding

As this school year is winding down, there are many school districts in our state that are scrambling to figure out how to fund their programs after losing state aid for the coming fiscal year. NJEA has been in contact with Governor Murphy's administration about the districts that are receiving less school funding under the Sweeney S-2 plan.

NJEA Research Division created a calculator allowing NJEA to identify the impact of state aid for every district and what the district can do to address it. This revealed that some districts are unable to raise the monies needed. These districts are going to need bridge funding and must identify additional options to consider.

New Jersey Gov. Phil Murphy made a brief, surprise visit to the March 30th meeting of the NJEA Delegate Assembly. Murphy expressed pride in working alongside organizations, such as NJEA, that represent public employees. Murphy noted that, although the state has restored nearly \$500 million dollars in state aid to schools over the last two years, there are some districts facing funding challenges. Governor Murphy said, "I have directed the Department of Education—including and beginning with the commissioner—to work alongside those school districts to ensure that we're looking out for everyone."

NJEA is working collaboratively with its partners, along with a coalition of superintendents, as well as the local association presidents and field reps from those districts affected by the funding cuts. These stakeholders met in April to learn about the nature of the funding problems faced by many of the 197 districts whose state aid is being reduced, and to agree upon a game plan. The meeting included presentations by the Education Law Center and NJEA staff.

This statewide school funding joint coalition is asking to sit down with the governor and legislative leadership to address this year's funding problems and to also discuss a more permanent solution. In addition, NJEA continues to work with individual local affiliates to analyze their funding situations and discuss possible solutions. These analyses show that there are dozens of different causes of funding shortfalls, but the remedies must originate in the same place – the State Legislature.

As advocates for students and public education, we must urge the governor and legislators to begin working together now with public education stakeholders to ensure that future funding allocations meet the needs of every student in every community. Stay informed through your local and county associations and the

MCEA and NJEA websites.

In a few months, I will be stepping down from my position as the Monmouth County NJEA Executive Committee member due to my retirement. It has been a pleasure representing our county in this capacity and I look forward to continuing to advocate for students and public education through the very active New Jersey Retirees' Education Association. I wish Jo-Anne Montanti all the best when she begins her very exciting and active position as Monmouth County's Executive Committee member.

Stay Involved After Retirement

Some of you will be retiring at the end of the school year, and we want to welcome you to the Monmouth County Retired Educators' Association. Upon your retirement, you will receive a letter from NJEA/NJREA to join the New Jersey Retired Educators' Association. Association membership is one of the best investments a retiree can make, especially in the current political climate. As a member of NJREA, you have access to a variety of resources to get the most of your retirement, as well as peace of mind knowing there are people working on your behalf to protect it. We encourage you to maintain your membership so you will have the benefits you had as an active NJEA member. Some of the benefits are quarterly publications, professional assistance with medical benefits and pension questions, discounted legal services, Buyer's Edge, NJEA Travel, and NEA insurance and financial programs. In addition, you will have opportunities to meet with other Monmouth County Retirees four times a year for informational luncheons and participate in local philanthropic endeavors.

Your dues payment covers membership in NJREA, NJEA, NEA, and MCREA. Current Life Membership for professionals is \$1,200 and for ESP members it is \$810. These amounts are good until August 31, 2019. As of September, Life Membership will increase to \$1265 for professionals and \$875 for ESP Members. An actively employed professional or educational support staff member who is eligible for a NJ state pension may join NJREA prior to retirement at the current lifetime dues rate. An employee who elects NJREA pre-retirement lifetime membership may pay the dues in installment payments during one school year. The NJEA will bill the employee monthly. Dues may not be deducted from the employee's salary. For more details about this opportunity and payment installment options, call the NJEA Membership Division at 609-599-4561, ext.4123.
